Are we required to purchase from the Preferred Vendor contract?

This vendor has been designated as the "Preferred Vendor" for AU for this particular commodity as the result of a competitive bid process. What are the delivery terms?

Nikon shall deliver the specified quantity of Products to the destination specified by Customer in accordance with the declared delivery date specified in the order acknowledgement. Nikon shall arrange all deliveries through a reputable commercial carrier to be determined by Nikon or through the Nikon Instruments, Inc. 01-2019 Page 2 Supplier's delivery personnel. Nikon shall be responsible for freight costs of shipments. Delivery shall be FOB Destination Freight Prepaid and Allow.

What is Nikon's return policy?

Product must be new, unmarked and in original packaging with all warranty information as originally supplied. All such Product returned as defective must also be accompanied by a letter that clearly states the problem and shall be subject to inspection and verification by Nikon. All Product determined by Nikon, at Nikon's sole discretion, to be defective will be exchanged on a unit-by-unit basis, subject to availability, and if not available, the Product will be repaired as expeditiously as is reasonably possible and in the event that any such repair cannot be completed within sixty (60) days after Nikon's receipt of the Product, a credit shall be issued to the Participating Member in the amount actually paid for such Product. All Product returned to Nikon with Nikon's prior authorization in its sole discretion for a reason other than as defective, or that is determined by Nikon not to be defective, is subject to a fifteen (15%) percent restocking charge. All authorized returns must be shipped prepaid with a statement of the original invoice number and date, and delivered to a certified carrier within fifteen (15) days of issuance of the RA. If at Nikon's sole discretion a product is determined to be defective, shipping costs will be reimbursed. Any Products returned without prior authorization from Nikon will be returned to the Participating Member at the Participating Member's expense. Return requests for special orders, custom orders, or specific equipment requiring special factory orders will not be accepted at any time.
