
Will my Lowes For Pros Key fob will it still work?

No, effective 05/01/2023 the key fobs will no longer work. You must have a Lowes For Pros Account set up under the university account.

How to register for a Lowes's for Pro Account?

- 1. Go to Lowes.com and select Create Account.
- 2. Choose Business Account and select Continue.
- 3. Enter Pro Account ID: C94827E023 in the Join Existing field and select Next.
- 4. Enter all required fields to create login and password.
- 5. Go to My Account and select Wallet.
- 6. Under Payment Methods, click + Add New Card and enter your Auburn University PCard information.

How can I tell if my Lowe's For Pros Account is under the universities Lowe's For Pros Business Account? Go to Lowes.com and select "Organization Settings" then select "Organizational Settings", you should see Auburn University and the ProAccount ID# C94827E023 (See screenshot for example.)



Do I need to make an account if I am only making in-store purchases?

Yes, your AU-issued PCard must be set up in the ewallet of your Lowe's Auburn University business account online to be eligible for tax exempted purchases in store and online.

My order is not showing up as tax exempt when I am checking out.

- Your AU-issued PCard must be set up in the ewallet of your Lowe's Auburn University business account online to be eligible for tax exempted purchases in store and online.
- Order must be delivered or picked up in the state of Alabama. Auburn University tax exempt certificate is only good for orders picked up and delivered in the state of Alabama.
